



TERMS AND CONDITIONS (Candidate Registration)

The Terms and Conditions may be subject to change at any time without any notice. You are therefore obliged to go through this Terms and Conditions document from time to time. By registering to the **NSEIT DEX EDTECH** program you agree to be bound by the Terms and Conditions mentioned herein. If you do not agree we urge you not to use or access this program.

1. Candidate agrees that if his/her Application Form is incomplete, incomprehensible and/or incorrectly submitted then it may not be considered.
2. The Candidate agrees and expressly states that he/she is solely responsible for the accuracy and completeness of the Registration Data provided. The Candidate ensures that the data shared with NSEIT doesn't contain any fraudulent, false, misleading or manipulated information.
3. By registering for the program, the Candidate voluntarily submits and agrees to a complete background check to be done by NSEIT.
4. The Candidate ensures that if required, he/she will comply with necessary documentation that shall enable NSEIT to complete the background verification upto its satisfaction.
